Mr. E'ava Sotutu Geita biography

In Fava Sotutu Geita is currently the Acting Solicitor General of Papua New Guinea. He holds a Master of Law (LLM) from the University of Melbourne and a Bachelor of Law (LLB) from the University of Papua New Guinea (UPNG).

Recently appointed in March 2024, Mr. Geita previously served as Acting Deputy Secretary for Corporate Affairs and General Administration since 2023. His previous roles include Deputy Solicitor General, State Defense, for 11 years.

With over 21 years of experience in the legal profession in both public and private sectors, Mr. Geita brings extensive knowledge and expertise to his current position.

The Judicial and Legal Service Commission (JLSC) recently appointed Mr. E'ava Geita as the Acting Solicitor General of Papua New Guinea

The Minister for Justice and Attorney General, and Chairman of JLSC, Hon. Pila Niningi, announced this appointment during a press conference held on Wednesday 13th of March, 2024. The Minister, thanked the outgoing Solicitor General, Mr. Tauvasa Tanuvasa and acknowledged his role and leadership in the office in the last 5 years. He wish Mr. Tanuvasa all the best in his future endeavors.

He noted that the term of the outgoing Solicitor General, Mr. Tauvasa Tanuvasa, had expired. "Mr. Geita's appointment as Acting Solicitor General will continue for an indefinite period until JLSC makes a decision," he said.

The Office of the Solicitor General

he office of the Solicitor General is a deemed department under the department of Justice & Attorney General.

The office of the Solicitor General is established under the *Attorney General's Act 1989.* It has five Divisions which are: Judicial Review & Commercial; Police; Torts & Negligence; Regional Operations; and Cost & Taxation. In those Divisions, the Solicitor General defends government agencies in Court with the aim of reducing the number of claims and the liability of government in monetary damages.

In short, the Solicitor General is responsible for providing litigation services and cost recovery services to the executive government, government departments, and provincial governments.

These services include defending these governments entities or refered to as State in Court or in other adversarial or quasijudicial forums.



DJAG set to address Corruption Risk Assessment and Mitigation Plans to improve governance processes

Officers undertake Corruption Risk Assessment and Mitigation Plans Training

ore than 30 officers from the Department of Justice & Attorney General (DJAG) recently participated in the Corruption Risk Assessment and Mitigation Plans Training held on Thursday 4th of April at Lamana Hotel in Port Moresby. This training equips them with the skills needed to identify and manage corruption risks within the department and to improve governance processes.

The initiative, funded by the European Union and implemented by the United Nations Development Program (UNDP) with support from DJAG, is part of the Preventing and Countering Corruption effort. It underscores the government's commitment to combating corrupt practices within the public sector and across Papua New Guinea.

Dr. Eric Kwa: "Be the light, fight against corrupt practices."

"Stand up and don't stay silent about corrupt practices within the Department of Justice & Attorney General."

"If the public perceives the Public Service as corrupted, then the Department of Justice must rise and set the example as a corruption-free organization, shedding light on integrity and accountability," he said.

Dr. Kwa's perception on Corruption

Puring his keynote speech, Secretary for the Department of Justice Justice and Attorney General Dr. Eric Kwa stressed the critical role that each individual public servant must play in combating corruption. He stressed the importance of adopting a mindset focused on doing what is right and ethical to combat corrupt behavior and practices.

Highlighting the important role that the Department of Justice and Attorney General (DJAG) played in the establishment of the Independent Commission Against Corruption (ICAC), Dr. Kwa emphasized the need for the department to set an example of good governance practices.

Dr. Kwa urged department staff to take full advantage of the training provided to identify and address corruption risks and threats within their operations.

He also thanked the United Nations Development Program (UNDP) for their support in organizing and facilitating the training sessions.

Core Committee Meeting for the National Action Plan (NAP) against Sorcery Accusation Related Violence (SARV) was successfully carried out in Mt Hagen recently with more than 60 participants from the Highlands Region.

Speaking at the gathering Deputy Secretary (Justice Administration), Mrs. Josephine Pitmur stressed the importance of having a good and strong partnership in this fight to curb sorcery accusation related violence.

Mrs. Pitmur said good partnership and communication with each other is the way forward for all of us dealing with SARV in the country; if we work well together, we will see great results.

"At the end of the day, we will find the solutions to our own problems and no one outside will do it. We are the experts in our field and what we do in this space. Donors will come and go but we will remain in our country with these issues," she said.

"Hence, we must learn to work closely with each other; that is the State and Non-State Actors and the communities. In this space, partnership is very vital and there is no room for us to work in isolation but to hold each other's hand and move forward," she said.

Mrs. Pitmur was also impressed to see a fair representation from both genders and a good number of the younger generation in the room of participants.

"I am pleased to see a good number of men participating in this program. SARV work needs a lot of male champions to help stand alongside our mothers, sisters and daughters who are very vulnerable in these situations. I acknowledge the men in the room, thank you for taking up the challenge to stand up for the women of this country," she said.

On that note, she also encouraged the younger generation to work closely with the older generation so that knowledge can be passed on.

The three-day program was co-funded by OxFam PNG along with the Department of Justice and Attorney General.

Participants from State and Non-State Actors including civil society organizations, churches and community leaders attended the program held at the Highlander Hotel, Mt Hagen.

DJAG Enhances Transportation, Vehicle Management and Security

Installation of Tracking System

The Department of Justice and Attorney General (DJAG) has signed a contract with the Brave Security Consortium in 2021 to provide vehicles tracking security service and other related support services to the department.

In an effort to bolster accountability in fleet management and reinforce vehicle security, the department has recently made a significant investment by acquiring seven new Sports Utility Vehicles (SUVs). These vehicles have been specifically designated for use by Deputy Secretaries and Branch Heads within the Department.

This proactive measure was initiated following explicit directives from Department Secretary Dr. Eric Kwa, who recognized the critical need for improved oversight and security measures within the department's transportation infrastructure. Consequently, the decision was made to outfit the newly acquired SUVs and all other vehicles with state-ofthe-art vehicles security trackers.

These cutting-edge tracking systems have been strategically deployed with the primary objective of enhancing accountability in fleet management and fortifying the security of departmental vehicles. By implementing these measures, DJAG aims to optimize transportation services, ensuring swift and secure mobility for its various Divisions and Branch Heads.

With the incorporation of these seven new SUVs, DJAG's fleet now boasts a total of 35 vehicles. Each vehicle, including the recent acquisitions, is equipped with the Vehicles' Monitoring (DJAG_VTM) software, enabling real-time monitoring and management capabilities to further streamline operational efficiency and ensure the highest standards of safety and accountability.

New Vehicles Allocated to Branch Heads

On April 25th, 2024, an exciting event unfolded in the department as nine new vehicles were purchased and distributed to selected branch heads during the lunch break.

Among these vehicles were six Haval, one Proton, one Kia, and one Hyundai Tucson, totaling nine in all.

Secretary Dr. Eric Kwa in his address to the branch heads, emphasized on the policies in place, including GPS usage, and the consequences of breaching these policies. Dr. Kwa mentioned that this was the third round of vehicle distribution and encouraged those who did not receive a vehicle on that day to await future opportunities.

Following the briefing, the Department's Pastor Daniel Hewali led a prayer, committing the vehicles and their recipients to a sense of responsibility. The Pastor advised the recipients to take accountability for this opportunity.

The vehicle keys were handed over to the branch heads by the Fleet team, led by Mr. Forova, fleet coordinator.





National Women's Day Address: Ms. Kalamo Urges Daily Recognition and Calls for Action

n her address during the National Women's Day celebration held on the 25th of March at Gateway Hotel in Port Moresby, Ms. Teisi Kalamo, the Gender Equality, Disability and Social Inclusion (GEDSI) Manager, emphasized the importance of recognizing and supporting women and made calls for action.

Marking the National Women's Day, Ms. Kalamo highlighted the theme "Count her In: Invest in Women, Accelerate Progress," is a Global Theme that echoes the call to empower women and girls.

Ms. Kalamo stressed the need for daily acknowledgment of women's contributions in the department. She highlighted the challenges faced by women within the department in accessing training opportunities, revealing a lack of awareness of their rights.

She made calls for action and commitment in the following areas:

Removing Systematic Barriers: "It is imperative to eliminate obstacles preventing both women and men from reaching their full potential. This responsibility lies with all Branch Heads and the Department of Personnel Management (DPM), particularly in reviewing the Public Service General Orders (PSGO). Laws and policies must be sensitive to the current socio-economic situations, acknowledging challenges such as transportation issues impacting punctuality. Instead of penalizing tardiness, reasonable accommodation should be made for parents juggling work and childcare responsibilities. Such actions are essential to addressing pervasive inequalities and support all individuals, irrespective of gender, in fulfilling their roles effectively." **Prioritizing Data Governance:** "Data governance must be a priority to understand the impact of investing in women, such as through further training programs. Qualitative research conducted by the HRM and Research and Development branches can shed light on these outcomes, enabling informed decision-making and resource allocation."

Revisiting PNG Ways: "It is crucial to revisit traditional Papua New Guinean values and integrate local contextualized interpretations into internal workplace policies. This responsibility also falls on all Branch Heads, emphasizing the foundation of respect in guiding workplace behaviour and interactions."

She said, "these calls for action aim to unlock the power of mutual respect and inclusivity, creating an environment where individuals can thrive and contribute meaningfully."

"One year from now, let's review these calls to action or commitments to measure our performance as the agency entrusted with one of the most crucial responsibilities: providing law and community justice services to our people," she stated.

Ms. Teisi Kalamo Appointed Chair of Law and Justice Sector GEDSI CoP

In acknowledgment of her contributions to advancing Gender Equality, Disability and Social Inclusion (GEDSI) within the Department of Justice & Attorney General (DJAG) and as well as in the Law and Justice Sector (LJS), GEDSI Manager Ms. Teisi Kalamo has been appointed as the Chair of the Law and Justice Sector Gender Equality and Social Inclusion (GEDSI) Community of Practice (CoP).
